## What is VIYP?

Vancouver Island Youth Parliament (VIYP) is a non-profit, non-partisan youth organization that recognises every young person's potential to lead and serve in their community. VIYP's aim has been to provide a forum in which young people can develop skills in leadership, public speaking, and the parliamentary process, and put these skills into practice through service to youth in their community. VIYP recognizes the ability of many youth and provides a forum in which youth can have their chance to be heard. ## What Happens During Session?

VIYP's year begins with a Parliamentary Session. Session runs from 6:00pm on March 26 to 12:00pm on March 28 and will be held at Victoria City Hall. **Members must attend all of Session and must contact the Chief Returning Officer before applying if this presents a problem.**

**Debate** - discuss Cabinet's legislation which sets out VIYP's activities for 2010.

**Think** - debate local, national, and international issues of your own choosing.

**Learn** - the rules of parliamentary procedure.

**Exercise Democracy** - elect VIYP's Premier and Leader of the Opposition for the next year's Parliament.

**Socialize** - meet youth from all over Vancouver Island. There will be a social dinner at Earls Restaurant on Saturday evening; members will be responsible for the cost of their own meal.

## What Happens After Session?

**Action** - put the legislation into action by participating in service projects, social events, fundraising and more.

**Shout Out** - get out and make our voice heard.

**Participation** - participate in projects and help out in the community.

**Remember** - receive a VIYP journal which documents the events of session

## Travel and Sessional Arrangements

Parliamentary Session will be held at City Hall in Victoria. All members that do not live in the Greater Victoria area, if needed, will be billeted with local members. All meals, with the exception of lunch on Saturday, is the responsibility of the members. **Members needing billeting and/or assistance arranging transportation or who are able to carpool should contact the Chief Returning Officer.**

## Who can join?

Each year youth are "elected" to become Members of VIYP as representatives of their schools or community organizations. To be eligible to stand for "election" you must be:

- a resident of or attending school on Vancouver Island, the Gulf Islands or Upper Sunshine Coast;
- between the ages of 14 and 18 (inclusive) as of December 31, 2010;
- nominated by an organization committed to youth (i.e. a school, community group, club or church);
- willing to participate fully in activities throughout the year.

Individuals from outside the recruitment area who meet the age and nomination requirements may apply to attend VIYP as Ambassadors. Such applicants should follow the normal application process and indicate their intention to apply as an Ambassador to the Chief Returning Officer.

## Application Process:

Follow these simple steps and come join us!

1. *Complete all aspects of this application form* (personal info, emergency medical info, sponsorship info, consent and waiver, publicity and promotional consent, personal information consent).
2. *Attach a \$30.00 registration fee.* The registration fee includes lunch and snacks on Friday. Members are responsible for the cost of all other meals. **Cheques must be made payable to British Columbia Youth Parliament.** Please note that bursaries to attend VIYP are available for applicants who demonstrate need for financial assistance. Applicants should indicate their intention to apply for a bursary in a short letter attached to their application. Fees for applicants not accepted will be immediately returned. Fees for accepted applicants who cancel on or after March 20 will not be refunded.
3. *Attach a one-page resume (optional).*
